## POWER 94.9 / 101.9 "NOAH KAHAN ONLINE" CONTEST OFFICIAL RULES

The Station will conduct the **93.3 THE BULL "NOAH KAHAN ONLINE" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 PM MT on July 4, 2024 to be eligible for a chance to win a prize. Failure to respond to the initial verification contact within Twenty Four Hours (24) hours of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
