## POWER 94.9/101.9 " MELANIE MARTINEZ TEXT CONTEST" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KENZ ("Station"), 434 Bearcat Drive, Salt Lake City, UT 84115, during available business hours Monday through Friday, on the Station website www.Powerslc.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **POWER 94.9/101.9 "MELANIE MARTINEZ TEXT CONTEST" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
