POWER 94.9/101.9 "LANY TEXT CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **POWER 94.9/101.9 "LANY TEXT CONTEST" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
