## KENZ "BENSON BOONE ONLINE" CONTEST OFFICIAL RULES

The Station will conduct the **KENZ "BENSON BOONE ONLINE" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
